ANTIBIOTIC AWARENESS WEEK

Pharmacists are encouraged to stop and reflect on their antimicrobial stewardship.

The frequent use of antimicrobials in residential aged care facilities (RACFs) is of particular concern, as residents are often are vulnerable to infections due to their compromised immune status, multiple co-morbidities and poor functional status.



SOFTWARE HANDY HINT: Generate your 6CPA claim report

1. From the main screen select 'REPORTS'
2. Select 'DATABASE REPORTS'
3. Select '6CPA DAA CLAIM REPORT'
4. Select the facilities to be included in the report
5. Input data range for claim period
6. Select 'PREVIEW'
7. Check the information is correct in the report
8. Select 'EXPORT 6CPA'
9. Select the Save Directory (save as: .CSV format)
10. Select 'OK'



Note: Claims must be submitted before the end of the month that follows your claim period ie. For an October claim, you have till 30th November to submit your claim.
